4 On Oct. 31, Judge Colleen Kollar-Kotelly, a senior judge
5 in the District of Columbia, ruled against the Trump
6 administration in parts of the case involving the president's
7 executive order to restrict voting rights.

8 She entered a permanent injunction that prevented the
9 Election Assistance Commission (EAC) from implementing the
10 worst provision of Trump's executive order: one that would

11 require proof of citizenship to register to vote, such as a passport
12 or birth certificate.

13 Judge Kollar-Kotelly found that this requirement is an
14 unconstitutional violation of the separation of powers, given that
15 electoral rules belong to the states and Congress, not the
16 president. This is one of many examples of lower court judges
17 standing up for the rule of law as, of course, they should do.

18 Unfortunately, in these times, judges put themselves at
19 increasing personal risk in the form of threats, harassment, and
20 physical violence, when they perform their constitutionally sworn
21 duty.

22 These courageous judges deserve our visible
23 appreciation.

24 We encourage others to voice support in public ways,
25 such as letters to the editor in your own communities, to help
26 counter some of the vitriol against these judges as they do their
27 best to hold the line against a runaway wannabe dictator and all
28 those so willing to do his bidding.
