4 All those familiar with downtown Brattleboro know that  
5 it has a sizable homeless population. On a recent morning I was  
6 walking along Flat Street and passed by what looked to be a  
7 homeless person next to some Brattleboro Police officers.

8 What struck me most about the encounter was its  
9 respect, cordiality, and humanity. Yes, there seemed to be some  
10 kind of issue. No, the police were not treating the woman as an  
11 inferior person. There was even what sounded like light-hearted

12 conversation taking place. Also notable: some of the person's  
13 associates were standing nearby, concerned but not intimidated.

14 I don't know whether the BPD officers were part of the  
15 unarmed Brattleboro Resource Assistance Team or regular, armed  
16 officers, but it sure looked like they were carrying out their job  
17 duties like any caring town citizen would want them to do.

18 Thanks go to those officers! I also hope they feel positive  
19 reinforcement in treating other people this way while helping  
20 tend to a tough, seemingly intractable community problem.

21 Meanwhile, we have read that U.S. Immigration and  
22 Customs Enforcement (ICE) is offering signing bonuses of up to  
23 \$50,000 as part of a recruitment drive to hire new personnel. As  
24 we know, ICE agents currently don masks and wear no  
25 identification while going about their jobs, and they have at times  
26 treated suspected unlawful immigrants — and bystanders —  
27 roughly and callously to the point of great excess. At least a  
28 portion of those ICE employees have exhibited an attitude  
29 indicating that they think they are above the law and that they  
30 have cared not a whit about due process.

31 I hope our local law enforcement officers (including  
32 Vermont State Police, Windham County Sheriff officers, and  
33 Vermont National Guard troops) are not tempted to jump ship  
34 and work for ICE.

35 I also hope that they currently get real job satisfaction  
36 and fulfillment in treating human beings like human beings, not  
37 like cattle, instead of wanting to work for a federal agency that's  
38 shown repeated evidence of inhumanity.
